NEW TOWN HALL

A meeting was held for interior furnishings and waiting to receive the revised quote. The next progress meeting will be held Thursday March 10, 2022 at 9:00 am. There remain questions on the unit costs for the change order submitted by Schimmoeller Construction.

SUBDIVISION RULES AND REGULATIONS

The revisions were reviewed. Greg Bockrath stated that the last update was completed in 2006 and these revisions were due to ODOT and EPA requirements. Discussion held on if flat fees included were necessary, Mr. Jason Birkemeier did not feel these are necessary.
