RENTAL FEES:

- * WESTSIDE \$35 non-refundable fee. Shelter House closest to St Rte 114. Has restrooms located in it.
- * <u>FIRESIDE</u> \$35 non-refundable fee. Shelter House closest to restrooms and playground on the south side of Road M.
- * <u>PAVILION</u> \$45 non-refundable fee. Located on the south side of Road M, near 2-acre lake. Has restrooms located in it. May not be appropriate if very young children will be present.
- * <u>NORTHSIDE Patio</u> \$35 non-refundable fee. Patio is attached to the community building. Rental of this patio includes access to restrooms in the community building, but does not include access to the kitchen area.
- * <u>LION'S Den Meeting Room</u> \$55 non-refundable fee. Meeting room is located within the community building. Has restrooms. Includes use of kitchen counters and sinks, but not use of the appliances. (Renter's need to call (419) 796-9041 the week of rental for access code).

(May rent BOTH Northside Patio and Meeting Room together for \$ 70.00 non-refundable fee)

<u>WEDDING RENTALS:</u> Requires a THREE day rental – Day of wedding, the day before (for set-up) and the day after (for clean-up). Rental price for set-up will be ½ price of normal rental fee and rental for clean-up will also be ½ price of normal rental fee.

RENTAL RULES:

- 1) Please limit moving of picnic tables to a minimum. If tables are moved, you are expected to return them to the original location. No moving of tables from one shelter house to another.
- 2) You are expected to clean up the shelter house and surrounding area after use. Turn off lights.

- b. Park Board does their best to keep shelters clean and well-maintained, however the shelters are outdoor shelters and may need spot cleaning by renter on day of rental.
